ORDINANCE NO. 56-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,
KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN
THE COUNTY OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING PROPERTY
LOCATED AT 2730 WEST SECOND STREET, CONTAINING
1.36 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 31-82, heretofore passed by the Board
of Commissioners of the City of Owensboro, Kentucky, on May 11,
19 82, the City proposed to annex certain territory hereinafter more particularly
described, and

WHEREAS, said ordinance has been published in the official newspaper
for the City and more than sixty (60) days have passed since the enactment of
said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE
CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky,
an its boundary line is hereby extended so as to include within the limits of
the City of Owensboro that certain territory in the County of Daviess, State of
Kentucky, adjoining and being adjacent to the present boundary line of the City
of Owensboro, Kentucky, more particularly described as follows;

Beginning at a point in the south margin of U.S.
Highway 60 West (Second Street), said point also
being in the west margin of Kentucky Highway 331
(Ewing Road), said point also being in the present
city limits line; thence with the south margin of
U.S. Highway 60 and leaving Ewing Road in a
westerly direction 605.40 feet to a point; thence
leaving the south margin of U.S. Highway 60 south
5° 32' west 170 feet to a point; thence south 85°
48' east 100 feet to a point; thence north 5° 32'
east 170 feet to a point in the south margin of
U.S. Highway 60; thence crossing U.S. Highway 60
along the same bearing 60 feet to a point in the
north margin of U.S. Highway 60; thence with the
north margin of U.S. Highway 60 in an easterly
direction 705.40 feet to a point in the west
margin of Kentucky Highway 331 (Ewing Road);
thence crossing U. S. Highway 60 and in line
with the west margin of Kentucky Highway 331,
60 feet to the point of beginning and containing
1.36 acres, more or less.
