ORDINANCE NO. 57-82

SECRETARY OF STATE

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2616 PARRISH AVENUE, CONTAINING 0.822 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. <u>32-82</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>May 18</u>, 1982, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE

CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at a point in the south margin of Parrish Avenue, said point being 440 feet east of the east margin of Carter Road, said point also being in the present city limits line; thence with the south margin of Parrish Avenue in an easterly direction 18 feet to a point; thence leaving the south margin of Parrish Avenue in a southerly direction 200 feet to a point; thence in a westerly direction 18 feet to a point; thence south 4º 21' east 172.48 feet to a point, said point also being in the present city limits line; thence with the present city limits line south 84° 36' west 113.18 feet; thence north 3° 22' west 160.15 feet; thence north 3° 32' west 125.12 feet to a point; thence north 78° 23' east 51.93 feet to a point; thence north 78° 47' east 59.23 feet to a point; thence in a northerly direction 75 feet to the point of beginning and containing 0.822 acres, more or less.
