ORDINANCE NO. 87-82

SECRETARY OF STATE
COMMONWEALTH OF KY.

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN LAKEWOOD SUBDIVISION, UNIT NO. 2-A, CONTAINING 4.74 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 67-82, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on September 21, 1982, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the City and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the east right-of-way of Raintree Drive; said point being the southwest corner of Lot No. 104, Unit No. 2-A, Lakewood Subdivision and also being in the present city limit line; thence with the present city limit line south 57 degrees 31 minutes west 55.7 feet to a point in the west right-of-way of Raintree Drive, said point being the southeast corner of Lot No. 96, Unit No. 2-A, Lakewood Subdivision; thence continuing with the present city limit line south 83 degrees 33 minutes west 329.72 feet to a point; thence departing from the present city limit line north 6 degrees 03 minutes west 300 feet to a point; thence north 83 degrees 07 minutes east 324.04 feet to a point in the west right-of-way of Raintree Drive; thence with said right-of-way north 5 degrees 56 minutes west 297.96 feet to a point; thence north 56 degrees 17 minutes east 56.65 feet to a point in the east right-of-way of Raintree Drive, said point being the northwest corner of Lot No. 112, Unit No. 2-A, Lakewood Subdivision; thence north 84 degrees 05 minutes east 128.32 feet to a point; thence south 6 degrees 16 minutes east 339.28 feet to a point; thence south 7 degrees 10 minutes east 259.92 feet to a point, said point being the southeast corner of Lot No. 104, Unit No. 2-A,

Lakewood Subdivision; thence south 82 degrees
53 minutes west 129.85 feet to the point of
beginning, containing 4.74 acres.


