ORDINANCE NO. 89-82

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2740 WEST SECOND STREET, CONTAINING 0.99 OF AN ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 68-82, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on September 28, 1982, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of U. S. Highway 60 West (Second Street), said point also being approximately 705 feet west of the west margin of Kentucky Highway 331 (Ewing Road), said point also being in the present city limits line; thence leaving the north margin of U.S. Highway 60 and crossing said highway south 5° 32' west 458.98 feet, to a point; thence north 56° 03' west 113.61 feet to a point; thence north 5° 32' east 402.67 feet and crossing U.S. Highway 60 west to a point in the north margin of said highway; thence following the north margin of U.S. Highway 60 south 85° 48' east 100 feet to the point of beginning and containing 0.99 acres, more or less.

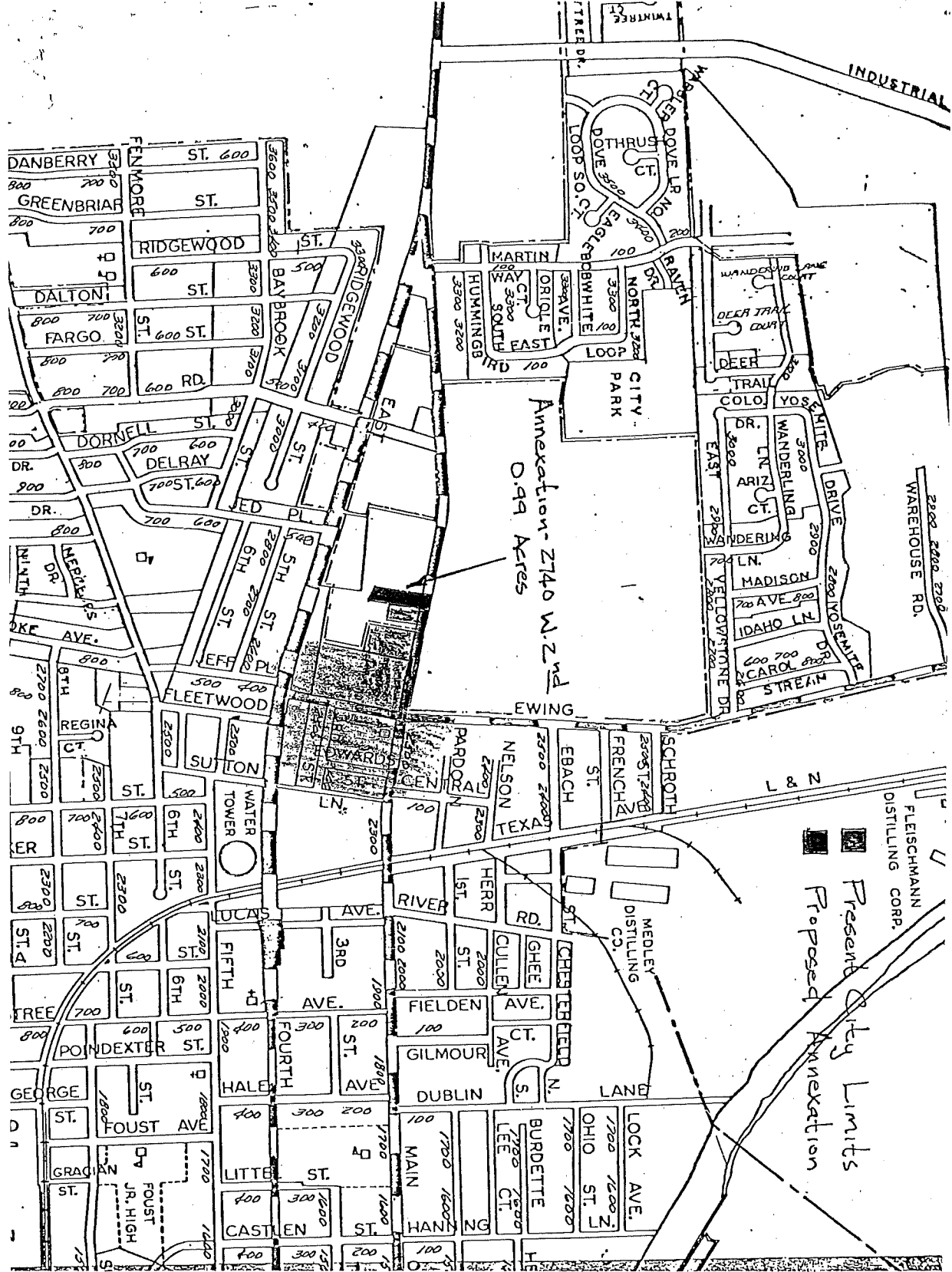
