ORDINANCE NO. 28-83

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,
KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN
THE COUNTY OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING PROPERTIES
LOCATED AT 2815, 2817, 2819 AND 2901 VEACH ROAD,
CONTAINING 0.80 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 8-83, heretofore passed by the Board of
Commissioners of the City of Owensboro, Kentucky, on February 7, 1983,
the City proposed to annex certain territory hereinafter more particularly
described, and

WHEREAS, said ordinance has been published in the official newspaper for
the city and more than sixty (60) days have passed since the enactment of said
ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS
FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky,
and its boundary line is hereby extended so as to include within the limits of
the City of Owensboro that certain territory in the County of Daviess, State of
Kentucky, adjoining and being adjacent to the present boundary line of the City
of Owensboro, Kentucky, a description of which is attached hereto and made a
part hereof.

SECTION 2. Any dedicated streets, alleys, or easements constituting any
portion of the property to be annexed are hereby accepted by the City of Owensboro
pursuant to KRS 82.400(2).

April, 1983.
