ORDINANCE NO. 45-83

SECRETARY OF STATE COMMONWEALTH OF KY.

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2700 PARRISH AVENUE, CONTAINING 1.185 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>19-83</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>April 11, 1983</u> the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at an iron pipe in the south rights of way of Parrish Avenue (Kentucky Highway No. 54, 56 and 81), said point being approximately 225.3 feet westward from the center of Carter Road and being 45.2 feet from the center of Parrish Avenue; thence South 2 degrees 06 minutes 20 seconds East 300.00 feet to an iron pipe; thence South 77 degrees 30 minutes West 175.00 feet to an iron pipe; thence North 2 degrees 06 minutes 20 seconds West 300.00 feet to an iron pipe in the south rights of way of Parrish Avenue, said point being 44.8 feet from the roadway center; thence North 77 degrees 30 minutes East 175.00 feet with the south rights of way of Parrish Avenue to the point of beginning, containing 1.185 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
