ORDINANCE NO. 49-83

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTIES LOCATED AT 2530 TAMARACK ROAD AND 3905 CARTER ROAD, CONTAINING 3.24 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 29-83, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on May 2, 1983, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the south margin of Tamarack Road, said point also being in the east margin of Carter Road; thence with the south margin of Tamarack Road South $77^{\circ} 18'$ East 200.11 feet to a point; thence leaving the south margin of Tamarack Road South $14^{\circ} 20'$ West 276.0 feet to a point; thence South $77^{\circ} 18'$ East 156.0 feet to a point being in the present city limits line; thence with the present city limits line South $14^{\circ} 20'$ West 250 feet to a point; thence North $77^{\circ} 17'$ West 346.36 feet to a point in the east margin of Carter Road; thence with the east margin of Carter Road North $13^{\circ} 31'$ East 401.54 feet to a point; thence North $12^{\circ} 30'$ East 124.15 feet to the point of beginning and containing 3.24 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

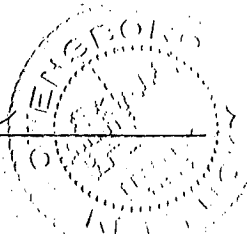
