ORDINANCE NO. 60-83

SECRETARY OF STATE
COMMONWEALTH OF KY.

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,
KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN
THE COUNTY OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING PROPERTY
LOCATED AT 2100 AND 2110 PARRISH AVENUE, AND
1518 BOSLEY ROAD, CONTAINING 0.98 ACRES, MORE
OR LESS

WHEREAS, by Ordinance No. 46-83, heretofore passed by the Board of
Commissioners of the City of Owensboro, Kentucky, on July 11, 1983,
the City proposed to annex certain territory hereinafter more particularly
described, and

WHEREAS, said ordinance has been published in the official newspaper
for the city and waivers of the 60-day waiting period from all parties within the
territory to be annexed have been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS
FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky,
and its boundary line is hereby extended so as to include within the limits of
the City of Owensboro that certain territory in the County of Daviess, State of
Kentucky, adjoining and being adjacent to the present boundary line of the City
of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the south margin of Parrish
Avenue, said point also being in the west margin of
Bosley Road and being the northeast corner of the
property at 2100 Parrish Avenue and also being in
the present city limits line; thence with the west
margin of Bosley Road south 8° 30' east 190 feet to
a point in the north margin of a 12 foot east-west
public alley; thence with the north margin of said
alley south 80° 51' west 236.4 feet to a point;
thence leaving the north margin of said alley north
9° 25' west 175.95 feet to a point in the south
margin of Parrish Avenue; thence with the south margin
of Parrish Avenue as follows: North 77° 44' east
60.7 feet; north 77° 30' east 59.3 feet; north 77°
18' east 120 feet to the point of beginning and
containing 0.98 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

INTRODUCED AND PUBLICLY READ ON FIRST READING, this the 25th day of July, 1983.
