AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY KNOWN AS GOLFPVIEW SUBDIVISION, CONTAINING 8.74 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 47-83, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 11, 1983, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1: There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the present city limits line and the west right-of-way line of the Louisville and Nashville Railroad, said point being the south line of the Owensboro Country Club Property if extended; thence with the west right-of-way of the Louisville and Nashville Railroad North 11 Degrees 07 Minutes East 10.0 feet to a point; thence South 78 Degrees 53 Minutes East 452.0 feet; North 12 Degrees 52 Minutes East 353.50 feet to a point 10.0 feet west of Hartz-Taylor's west property line; thence South 77 Degrees 08 Minutes East 10.0 feet to a point in Hartz-Taylor's west line and 10.0 feet north of the southwest corner of Hartz-Taylor property; thence North 12 Degrees 52 Minutes East 839.65 feet; South 77 Degrees 03 Minutes East 514.97 feet; South 12 Degrees 47 Minutes West 562.91 feet; South 12 Degrees 45 Minutes West 221.91 feet; North 33 Degrees 02 Minutes West 141.57 feet; North 69 Degrees 12 Minutes West 186.24 feet; South 63 Degrees 33 Minutes West 297.35 feet to a point, said point being the southwest corner of the Hartz-Taylor property and in line of the Owensboro Country Club property; thence with line of Owensboro Country Club property South 12 Degrees 52 Minutes West 353.50 feet; North 78 Degrees 53 Minutes West 461.97 feet to the point of beginning and containing 8.74 acres, more or less.
