

ORDINANCE NO. 22-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,
KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN
THE COUNTY OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING 750 SALEM DRIVE,
CONTAINING 0.8 ACRES MORE OR LESS.

WHEREAS, by Ordinance No. 19-84, heretofore passed by the Board of
Commissioners of the City of Owensboro, Kentucky, on March 20, 1984, the City
proposed to annex certain territory hereinafter more particularly described,
and

WHEREAS, said ordinance has been published in the official newspaper
for the city and a waiver of the 60-day waiting period from the owner of the
property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS
FOLLOWS:

SECTION 1: There is hereby annexed to the City of Owensboro,
Kentucky, and its boundary line is hereby extended so as to include within the
limits of the City of Owensboro that certain territory in the County of Daviess,
State of Kentucky, adjoining and being adjacent to the present boundary line of
the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the east margin of Salem Drive,
said point also being approximately 232.5 feet east of
the east margin of U. S. Highway 431, said point also
being in the present city limits line; thence north 40
00' east 17.29 feet; thence north 27 16' east 49.79 feet;
thence north 15 14' east 50.35 feet; thence north 6 38'
east 60.43 feet to a point; thence leaving the east margin
of Salem Drive south 80 38' east approximately 192 feet;
thence south 10 28' west 176.51 feet; thence north 79
38' west 215.63 feet to the point of beginning and contain-
ing 0.8 acres, more or less.

SECTION 2: Any dedicated streets, alleys, or easements
constituting any portion of the property to be annexed are hereby accepted by
the City of Owensboro pursuant to KRS 82.400(2).


