

ORDINANCE NO. 30-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTIES LOCATED AT 3925 AND 4005 CARTER ROAD (ATLANTIS SWIM & TENNIS COURT CLUB PROPERTY), CONTAINING 2.81 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 20-84, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 3, 1984, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the east margin of Carter Road, said point being 525.69 feet south of the south margin of Tamarack Road and being in the present city limits line; thence south 77° 17' east 346.36 feet to a point; thence south 14° 20' west 359.02 feet to a point; thence north 75° 40' west 345.68 feet to a point in the east margin of Carter Road; thence with the east margin of Carter Road north 14° 31' east 256.66 feet; thence north 13° 31' east 92.58 feet to the point of beginning and containing 2.81 acres, more or less, and being Lot C and Lot D of the Edward L. Richards Redivision of Property on Carter Road.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
