ORDINANCE NO. 47-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2605 VEACH ROAD, CONTAINING 0.3 OF AN ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 32-84, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on May 15, 1984, the City proposed to annex certain territory hereinafter more particularly described,

and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the 60-day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1: There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at a point in the east margin of Veach Road, said point also being 201.4 feet north of the north margin of 27th Street and being the southwest corner of the property at 2605 Veach Road; thence continuing with the east margin of Veach Road in a northerly direction 67.5 feet to a point being the northwest corner of the property at 2605 Veach Road; thence leaving the east margin of Veach Road in an easterly direction 200 feet to a point; thence in a southerly direction 200 feet to the point; thence in a westerly direction 200 feet to the point of beginning and containing 0.3 acres, more or less.

SECTION 2: Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
