

ORDINANCE NO. 55-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING 603 SALEM DRIVE, CONTAINING 0.55 OF AN ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 46-84 heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on June 19, 1984, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Salem Drive, said point being the southwest corner of the property at 515 Salem Drive, said point also being approximately 225 feet west of the west margin of Marlboro Drive if extended; thence with the north margin of Salem Drive north 83 degrees 20' west 110.0 feet; thence north 6 degrees 40' east 216.00 feet; thence south 87 degrees 31' east 50.76 feet; thence south 84 degrees 10' east 59.30 feet; thence south 6 degrees 40' west 221.16 feet to the point of beginning and containing 0.55 of an acre, more or less

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
