ORDINANCE NO. 81-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO
PROPERTY LOCATED IN THE STARVIEW SUBDIVISION,
MORE PARTICULARLY THE ENTIRE PROPOSED DEVELOPMENT
LOCATED JUST WEST OF THE STARLIGHT DRIVE-IN THEATER
ON THE SOUTH SIDE OF KENTUCKY 81, CONTAINING 16.5
ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 65-84, heretofore passed by the Board of
Commissioners of the City of Owensboro, on September 4, 1984, the City proposed
to annex certain territory hereinafter more particularly described; and

WHEREAS, said ordinance has been published in the official newspaper
for the city and a waiver of the sixty (60) day waiting period from the owner of
the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS
FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro,
Kentucky, and its boundary line is hereby extended so as to include within the
limits of the City of Owensboro that certain territory in the County of Daviess,
State of Kentucky, adjoining and being adjacent to the present boundary line of
the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the south margin of Kentucky
Highways 54, 56 and 81 (Parrish Avenue), said point also
being approximately 950 feet west of the west margin of
Carter Road and being in the present city limits line;
thence with the south margin of Parrish Avenue in a
westerly direction approximately 1,050 feet to a point
being the northeast corner of the Starview Subdivision;
thence leaving the south margin of Parrish Avenue south
12 degrees 57 minutes East 1,326.32 feet to a point;
thence South 73 degrees 12 minutes West 250 feet; thence
South 72 degrees 23 minutes West 157.31 feet; thence
North 13 degrees 05 minutes West 1,328.52 feet to a
point in the south margin of Parrish Avenue; thence
crossing Parrish Avenue in a northerly direction approxi-
mately 140 feet to a point in the north margin of Parrish
Avenue; thence with the north of Parrish Avenue approxi-
mately 1,445 feet to a point; thence crossing Parrish
Avenue in a southerly direction approximately 110 feet to
the point of beginning and containing 16.5 acres, more or
less.

SECTION 2. Any dedicated streets, alleys, or easements constitut-
ing any portion of the property to be annexed are hereby accepted by the City of
Owensboro pursuant to KRS 82.400(2).
