ORDINANCE NO. 92-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED ON MEDLEY ROAD, CONTAINING 37.1 ACRES, MORE OR LESS, (OWENSBORO RIVERPORT PROPERTY)

WHEREAS, by Ordinance No. 82-84 heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 2, 1984, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the north margin of Kentucky Highway 331 (Medley Road), said point also being in the west margin of a north-south access road to the Owensboro Sewage Treatment Plant property; thence with the north margin of Kentucky 331 south 83 degrees 45 minutes 00 seconds west 1226.05 feet; south 83 degrees 45 minutes west 47.07 feet; thence north 84 degrees 39 minutes west; thence north 70 degrees 09 minutes west 37.09 feet; thence north 56 degrees 35 minutes west 45.55 feet; thence north 42 degrees 01 minutes west; thence north 25 degrees 45 minutes west 47.21 feet; thence north 10 degrees 23 minutes west 50.34 feet to a point in the east margin of River Road; thence with the east margin of River Road north 5 degrees 01 minutes west 413.04 feet; thence north 5 degrees 00 minutes 48 seconds west 585.91 feet to a point; thence leaving River Road north 84 degrees 05 minutes east 1295.93 feet to a point; thence south 12 degrees 06 minutes east 1188.26 feet to the point of beginning and containing 37.1 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

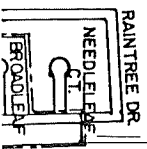

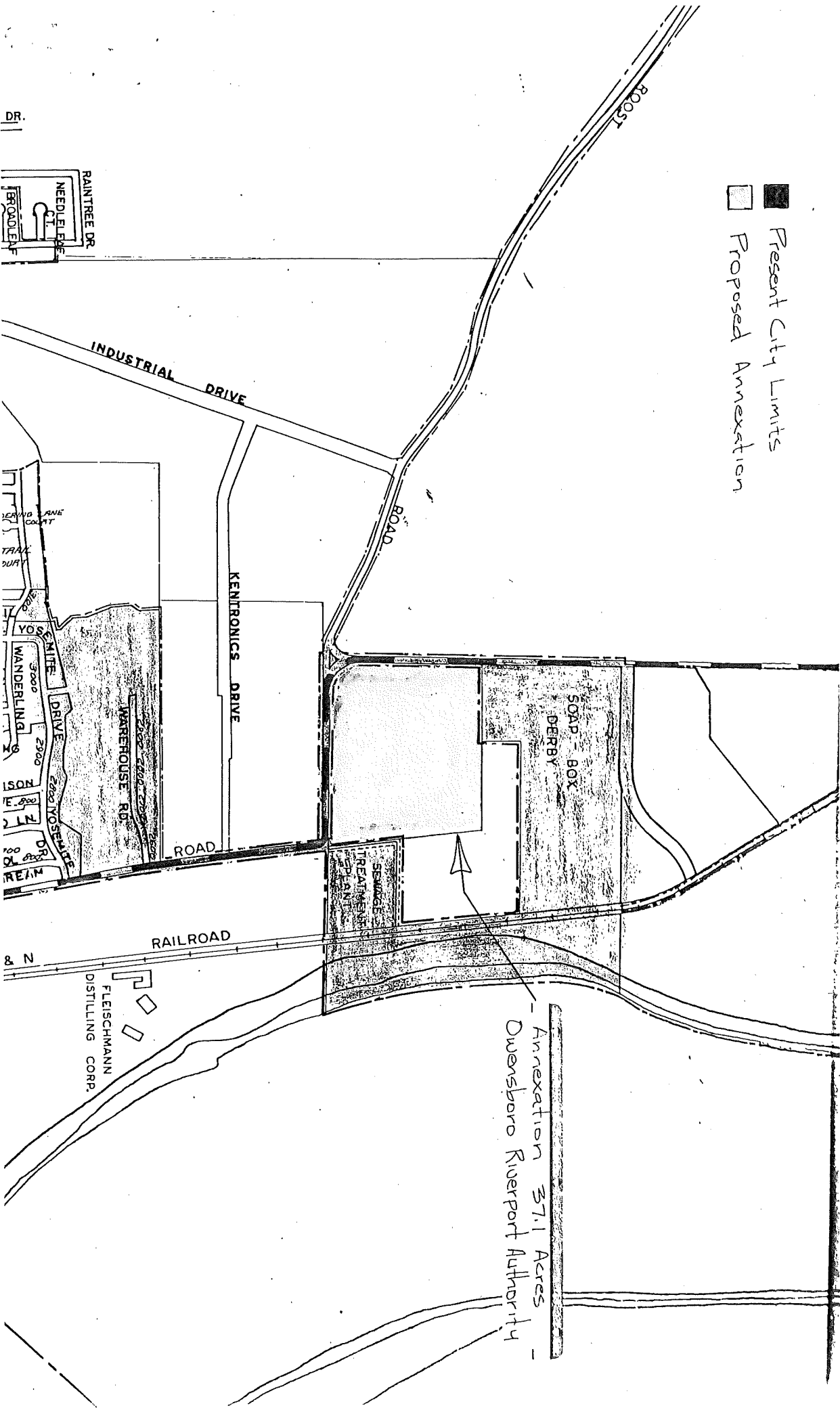
