AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 4101 BENTTREE DRIVE, CONTAINING 0.735 OF AN ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 84-84 heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 2, 1984, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a steel rod at the Northwest corner of Lot #18 in Unit #3 of the Lakewood Subdivision and in John A. Moore's East property line; thence with John A. Moore's property line N 18 degrees 08 minutes E 135.4 feet to an iron pipe and N 71 degrees 52 minutes W 85 feet to a steel rod, and N 18 degrees 08 minutes E 100 feet to a steel rod; thence with the Imperial Construction, Inc. property line, S 71 degrees 52 minutes E 185 feet to a steel rod and S 18 degrees 08 minutes W 235.40 feet to a steel rod; thence along the rear of Lots #19 and #18 N 71 degrees 52 minutes W 100 feet to the point of beginning and containing 0.735 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

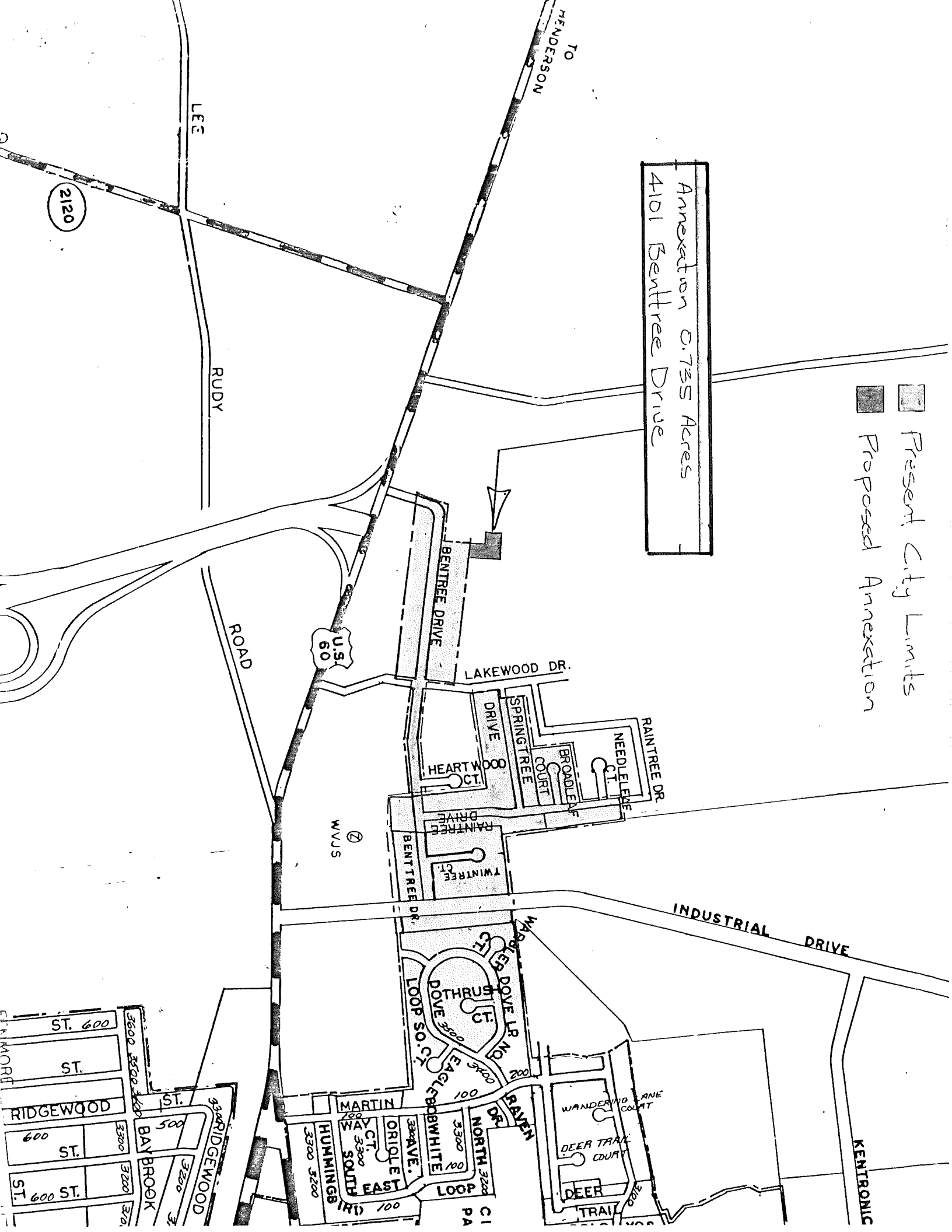
