ORDINANCE NO. 80-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY BEING PROPERTY LOCATED AT 2242 TAMARACK ROAD, CONTAINING 0.66 OF AN ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 62-84, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on September 4, 1984, the City proposed to annex certain territory hereinafter more particularly described; and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner for the property to be annexed has been received.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1: There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the south margin of Tamarack Road, said point also being in the east margin of Gemini Drive, and also being in the present city limits; thence with the south margin of Tamarack Road in an easterly direction approximately 120 feet to a point; thence leaving the south margin of Tamarack Road in a southerly direction approximately 240 feet to a point; thence in a westerly direction approximately 140 feet to a point in the east margin of Gemini Drive; thence with the east margin of Gemini Drive approximately 240 feet to the point of beginning and containing 0.66 acres, more or less.

SECTION 2: Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
