ORDINANCE NO. 106-84

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2950 VEACH ROAD, CONTAINING 0.81 OF AN ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 98-84 heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on November 20, 1984, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at a point in the west margin of Veach Road, said point being 368.41 feet south of Dixiana Court, said point also being the northeast corner of the property at 2950 Veach Road and being in the present city limits line; thence with the west margin of Veach Road south 32 degrees 21 minutes west 53.0 feet; thence south 28 degrees 34 minutes west 56.43 feet; thence leaving the west margin of Veach Road north 86 degrees 20 minutes west 331.86 feet; thence north 4 degrees 20 minutes east 99.25 feet; thence south 86 degrees 06 minutes east 379.91 feet to the point of beginning and containing 0.81 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
