ORDINANCE NO. 8-85

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2168 TAMARACK ROAD, CONTAINING .46 OF AN ACRE; MORE OR LESS

WHEREAS, by Ordinance No. 7-85, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 2, 1985, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the south right-of-way line of Tamarack Road, said point being the northeast corner of Lot No. 2 of the Herbert Bertke Subdivision as recorded in Deed Book 345, Page 684 and being address 2168 Tamarack Road, said point also being approximately 500' west of the west margin of Lovell Drive; thence south 2° 49' east 192.3' to a point in the north line of the Apollo Heights Subdivision and being the present city limits line; thence south 69° 30' west 109' to a point being the southwest corner of 2168 Tamarack Road; thence north 2° 49' west 192.3' to a point in the south margin of Tamarack Road; thence north 69° 30' east and with the south margin of Tamarack Road 109' to the point of beginning and containing .46 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

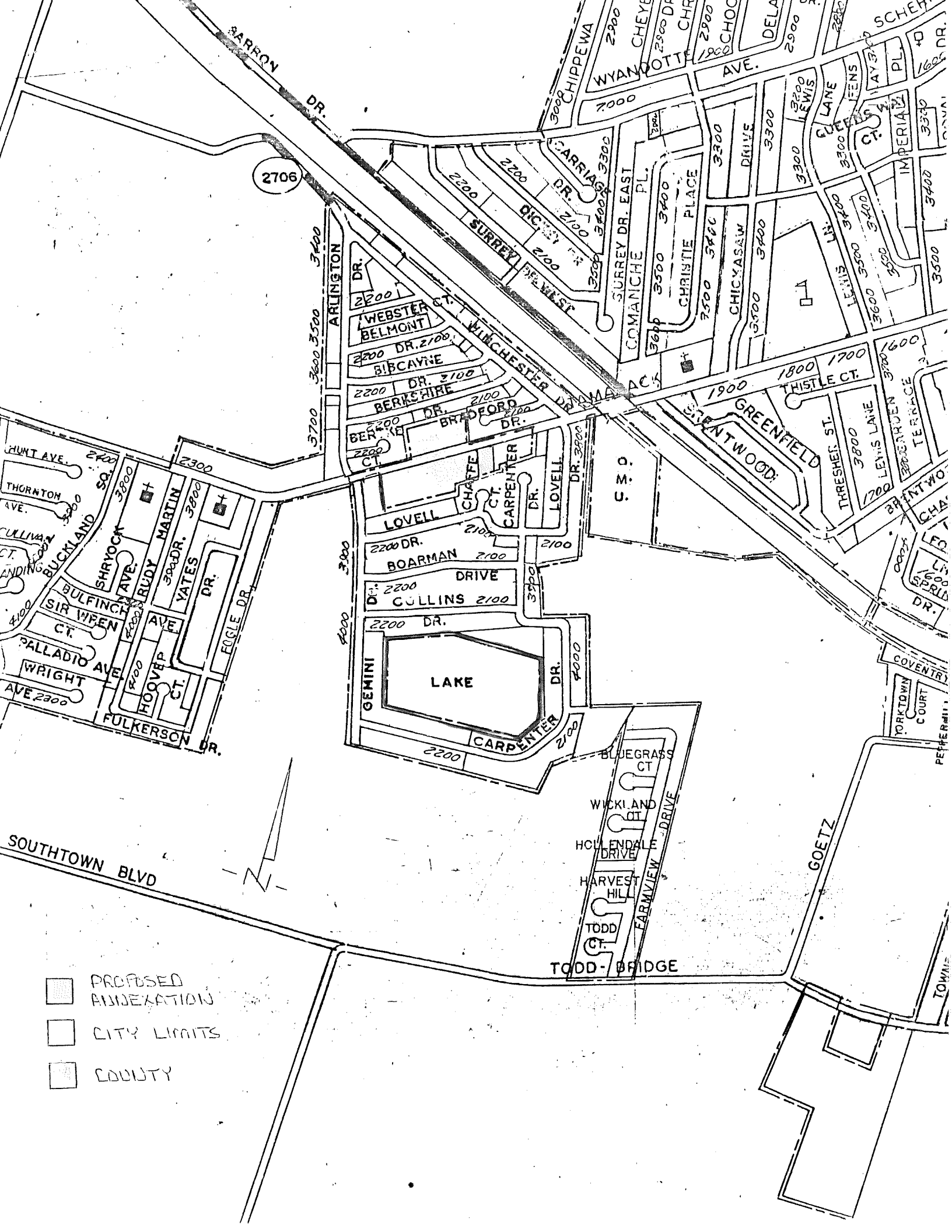
