ORDINANCE NO. 60-85

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1908 EAST 22ND STREET, CONTAINING 0.304 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 56-85, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on August 20, 1985, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the south margin of East 22nd Street, said point being 115 feet east of the east margin of a 25 foot wide public right-of-way called Railroad Street; thence N 75° 28' E 72 feet along the south margin of 22nd Street to a point; thence S 14° 32' E 239 feet to a point; thence N 46° 45' W 72 feet with the east margin of Railroad Street to a point; thence N 48° 54' W 59.2 feet with the east margin of Railroad Street to a point; thence N 14° 32' W 129.68 feet to the point of beginning and containing 0.304 acres.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
