ORDINANCE NO. 61-85

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT NO. 4 CLUB GROUNDS DRIVE, CONTAINING .820 OF AN ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 57-85, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on August 20, 1985, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe 100 feet north of the southeast corner of Golfview Subdivision and the southwest corner of Club Grounds Subdivision; thence N 12° 46' 42" E 337' along a line being the east margin of Golfview Subdivision and the west margin of Club Grounds Subdivision to an iron pipe being the northwest corner of No. 4 Club Grounds Drive; thence S 33° 30' 33" E 234.35' in the cul-de-sac of Club Grounds Drive; thence southwardly and with the west margin of the cul-de-sac 85 feet to the southeast corner of No. 4 Club Grounds Drive; thence S 57° 57' 12" W 203.19 feet to the point of beginning and containing .820 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

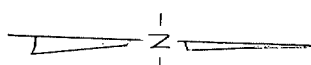
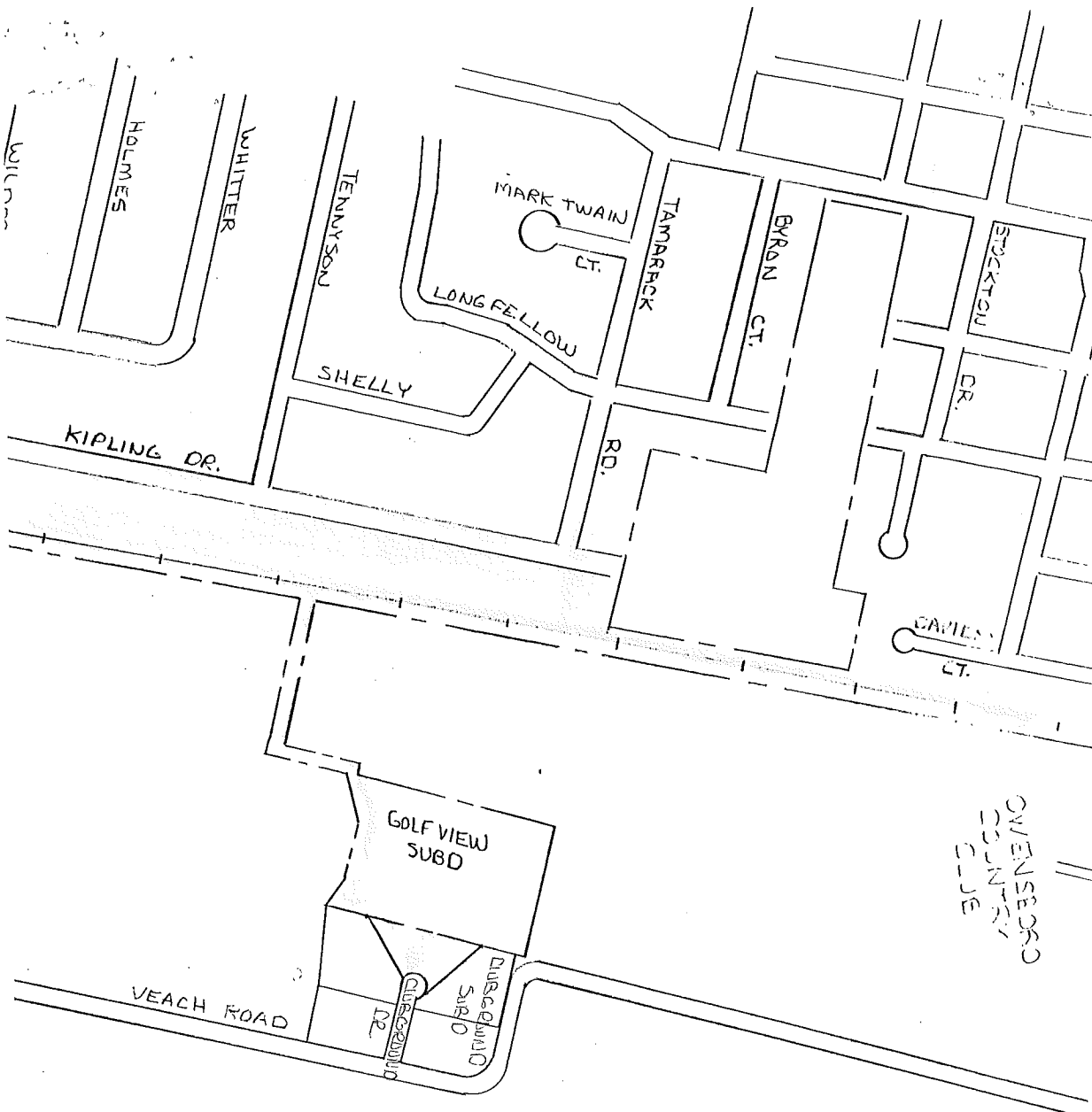
