ORDINANCE NO. 85-85

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS, ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTIES LOCATED IN THE VILLA POINT SHOPPING CENTER (WYNDALL'S MARKET & HOOK'S DRUGS), KY HWY. 54, CONTAINING 4.47 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 75-85, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on November 19, 1985 the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) days waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point where the north margin of Villa Point Drive intersects the east property line of the Villa Point Shopping Center; thence with the east property line S 22 degrees 32 minutes 05 seconds W 208.69 feet to a point; thence continuing with the east property line S 22 degrees 35 minutes 02 seconds W 400.32 feet to a point; thence N 73 degrees 07 minutes 34 seconds W and crossing Villa Point Drive to the west margin of Villa Point Drive; thence continuing N 73 degrees 07 minutes 34 seconds W 30.0 feet to a point; thence N 20 degrees 35 minutes 02 seconds E 40.0 feet to a point; thence N 73 degrees 07 minutes 34 seconds W 247.93 feet to a point; thence N 16 degrees 52 minutes 26 seconds E 620.64 feet to a point in the south margin of Villa Point Drive; thence S 65 degrees 42 minutes 15 seconds E with the south margin of Villa Point Drive and the present city limit approximately 270 feet to a point; thence N 22 degrees 32 minutes 05 seconds E and crossing Villa Point Drive 50.0 feet to the north margin of Villa Point Drive; thence S 65 degrees 42 minutes 15 seconds E with the north margin of Villa Point Drive and the present city limit approximately 100 feet to the point of beginning and containing 4.47 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
