OKDINANCE NU. 00-03

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS, ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY KNOWN AS QUAIL RIDGE CONDOMINIUM DEVELOP-MENT, SECTION II, CONTAINING 6 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>82-85</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>November 20, 1985</u>, the City proposed to annex certain territory hereinafter more particularly described, and WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the

property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at the southwest corner of Lot 516 of Unit 3 of Owen Park Subdivision, said corner being in the east margin of Meadowland Drive and being in the present city limits; thence with the west line of Quail Ridge Section I south 19 degrees 07 minutes west, 88.69 feet to a point; thence south 68 degrees 49 minutes east, 5 feet to a point; thence south 19 degrees 07 minutes west, 184.35 feet to a point; thence north 59 degrees 39 minutes west, 997.60 feet to a point; thence north 30 degrees 21 minutes east, 263.81 feet to a point; thence south 60 degrees 02 minutes east, 350 feet to a point; thence south 59 degrees 43 minutes east, 589.42 feet to a point of beginning and containing 6 acres, more or less.

SECTION 2. The streets in this development are private and will not be maintained by the City. The streets are part of the "common-ground" area of the development and will be the responsibility of the Condominium Corporation.
