ORDINANCE NO. 8-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 703 SALEM DRIVE, CONTAINING 0.703 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 5-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on February 4, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Salem Drive, said point also being in the present city limits line; thence N 88° 42' W 103.72 feet to a point; thence N 5° 37' E 30 feet to a point; thence N 84° 19' W 80.63 feet to a point; thence with the south margin of the Wendell Ford Expressway as follows: N 44° 00' E 64.45 feet, N 76° 20' E 170.34 feet, N 82° 49' E 126.79 feet; thence leaving the Expressway S 8° 06' W 126.50 feet to a point in the north margin of Salem Drive; thence with the north margin of Salem Drive as follows: N 81° 31' W 23.75 feet, N 89° 14' W 45.40 feet, S 80° 31' W 49.80 feet, S 55° 02' W 23.36 feet to the point of beginning and containing 0.703 acre.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

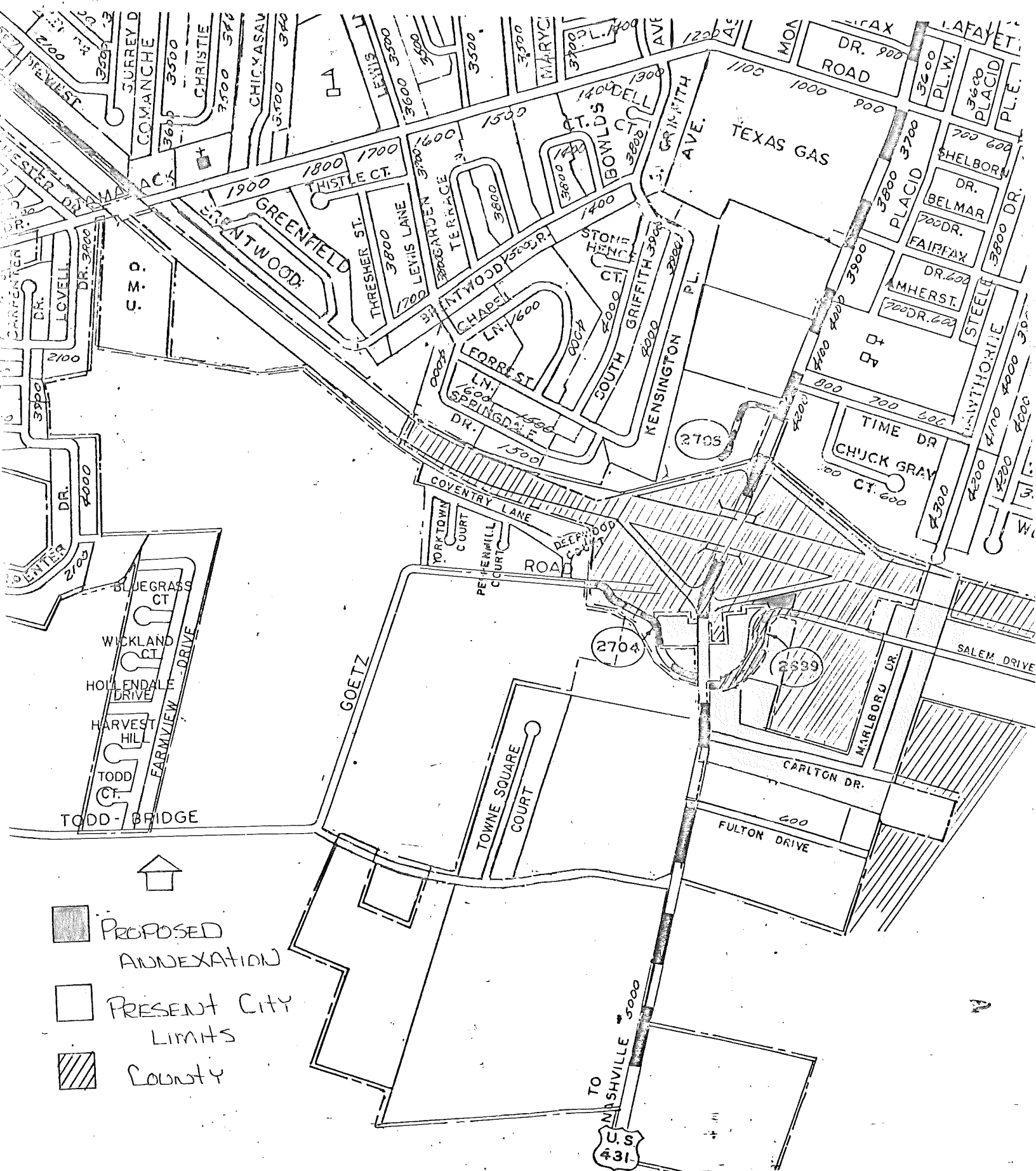
