ORDINANCE NO. 10-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY KNOWN AS UNIT NO. 6-A (SECTION NO. 3, LOT NOS. 622 THROUGH 628) IN OWEN PARK SUBDIVISION, CONTAINING 1.8 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 7-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on February 18, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Rogers Court, said point being in the present city limit line and being the southwest corner of lot #622 of Unit 6A of the Owen Park Subdivision; thence with the present city limit line and the west line of lot #622 N 29° 01' E 105.0' to a point; thence S 61° 21' E, 273.07' to a point; thence S 15° 16' W, 216.16' to a point; thence N 61° 29' W, 335.0' to a point being the southwest corner of lot #627 and being in the present city limit; thence with the present city limit and the west line of lot #627 N 28° 54' E, 101.01' to a point in the south margin of Rogers Court; thence crossing Rogers Court approximately 50.0 feet to the point of beginning and containing 1.8 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
