AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED IN OWEN PARK SUBDIVISION, UNIT 5-E, SECTION 2, CONTAINING 2.47 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 9-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 4, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

Beginning at a point in the east margin of Wilson Lane, said point being in the present city limit line and being the SW corner of Lot #584 of Unit 5-C of the Owen Park Subdivision; thence with the present city limit line S 67 degrees 50 minutes E, 145.85 feet to a point; thence S 27 degrees 37 minutes W, 434.82 feet to a point; thence N 59 degrees 29 minutes W, 150.53 feet to a point in the east margin of Wilson Lane; thence continuing N 59 degrees 29 minutes W and crossing Wilson Lane approximately 51 feet to a point in the west margin of Wilson Lane and being the south-east corner of Lot #579; thence N 22 degrees 10 minutes E, 86.16 feet to a point; thence N 67 degrees 50 minutes W, 104.53 feet to a point; thence N 19 degrees 09 minutes E, 302.40 feet to a point; thence S 67 degrees 50 minutes E, 120.43 feet to a point in the west margin of Wilson Lane, said point being the SE corner of Lot #574 of Owen Park Subdivision; thence crossing Wilson Lane approximately 55 feet to the point of beginning and containing 2.47 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
