ORDINANCE NO. 31-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING THE CITY PARK PROPERTY ON WEST FIFTH STREET ROAD, AND A PORTION OF THE RIGHT-OF-WAY OF FIFTH STREET ROAD FROM CARTER ROAD TO THE EXPRESSWAY, CONTAINING 41.4 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. <u>23-86</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 15, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at the point where the west margin of Carter Road intersects the south margin of Fifth Street Road, said point being in the present city limit; thence westward and with the south margin of Fifth Street Road approximately 2,570 feet to the point where the east line of City owned park property intersects the south margin of Fifth Street Road; thence with the east line of the park property S 16° 08' W 2,387.38 feet to a point in the east margin of the Wendell Ford Expressway; thence with the east margin of the Expressway N 28° 54' W 35.32 feet; N 17° 54' W 282.0 feet; N 19° 46' W 1,773.55 feet to a point in the south margin of Fifth Street Road; thence continuing N 190 46' W and crossing Fifth Street Road approximately 150 feet to the north margin of Fifth Street Road; thence eastward and with the north margin of Fifth Street Road approximately 4,050 feet to the west margin of Carter Road; thence southward and crossing Fifth Street Road to the point of beginning and containing 41.4 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
