ORDINANCE NO. 53-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1800 CARTER ROAD, CONTAINING 0.451 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 46-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 1, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe in the west right-of-way of Carter Road which is south 3 degrees 35 minutes east 390.4 feet from the intersection of the west right-of-way of Carter Road and the south right-of-way of Parrish Avenue and a corner to the Osborne Estate remaining land; thence with the west right-of-way of Carter Road and the present city limit south 3 degrees 35 minutes east 100.00 feet to an iron pipe corner to the Osborne Estate; thence with the lines of the Osborne Estate south 76 degrees 01 minutes west 200.00 feet to an iron pipe; thence north 3 degrees 35 minutes west 100.00 feet to an iron pipe; thence north 76 degrees 01 minutes east 200.00 feet to the point of beginning containing 0.451 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
