ORDINANCE NO. 58-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING THE GOOD SHEPHERD CHURCH PROPERTY LOCATED AT 3031 BITTEL ROAD, AND A PORTION OF BITTEL ROAD RIGHT-OF-WAY, CONTAINING 11.55 ACRES, MORE OR LESS

WHEREAS, by Ordinance No. 51-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 15, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at the point where the south margin of Bittel Road intersects the west line of Thorobred Acres Subdivision, Unit 8B and being in the present city limits; thence westward with the south margin of Bittel Road approximately 1330 feet to a point in the east margin of the Wendell Ford Expressway; thence northward and crossing Bittel Road to the point where the north margin of Bittel Road intersects the east margin of the expressway, being the southwest corner of the Good Shepherd Church Property; thence with the east margin of the expressway N 22° 59' W, 183.85 feet to a point; thence N 22° 35' W, 398.45 feet to a point; thence N 20° 57' W, 10.3 feet to a pipe; thence leaving the east margin of the expressway N 72° 33' E, 237 feet to a pipe; thence N 72° 51' E, 162.64 feet to a point; thence N 72° 40' E, 357.03 feet to the northeast corner of the Good Shepherd Church Property; thence S 12° 22' E, 651.97 feet to the north margin of Bittel Road; thence eastward and with the north margin of Bittel Road approximately 700 feet to the point where the west line of the Shifley Park Property intersects the north margin of Bittel Road; thence southward and crossing Bittel Road to the point of beginning and containing 11.55 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
