AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO,
KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN
THE COUNTY OF DAVIESS ADJOINING THE PRESENT
BOUNDARY LINE OF THE CITY, BEING PROPERTY
LOCATED AT 2508 NEW HARTFORD ROAD, CONTAINING
0.23 ACRE, MORE OR LESS

WHEREAS, by Ordinance No. 56-86, heretofore passed by the Board
of Commissioners of the City of Owensboro, Kentucky, on August 5, 1986, the
City proposed to annex certain territory hereinafter more particularly
described, and

WHEREAS, said ordinance has been published in the official
newspaper for the city and a waiver of the sixty (60) day waiting period from
the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY,
AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro,
Kentucky, and its boundary line is hereby extended so as to include within
the limits of the City of Owensboro that certain territory in the County of
Davies, State of Kentucky, adjoining and being adjacent to the present boundary
line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at the N.E. corner of 2508 New Hartford
Road and in the west right-of-way margin of
New Hartford Road and also being in the present
city limits; thence with the west margin of New
Hartford Road S 25° 55' E, 63.5 feet to a point;
thence leaving the west margin of New Hartford
Road S 64° 05' W, 160 feet to a point; thence N 25°
55' W, 63.5 feet to a point; thence with the
present city limits line N 64° 05' E, 160 feet to
the point of beginning and containing 0.23 acre,
more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting
any portion of the property to be annexed are hereby accepted by the City of
Owensboro pursuant to KRS 82.400(2).

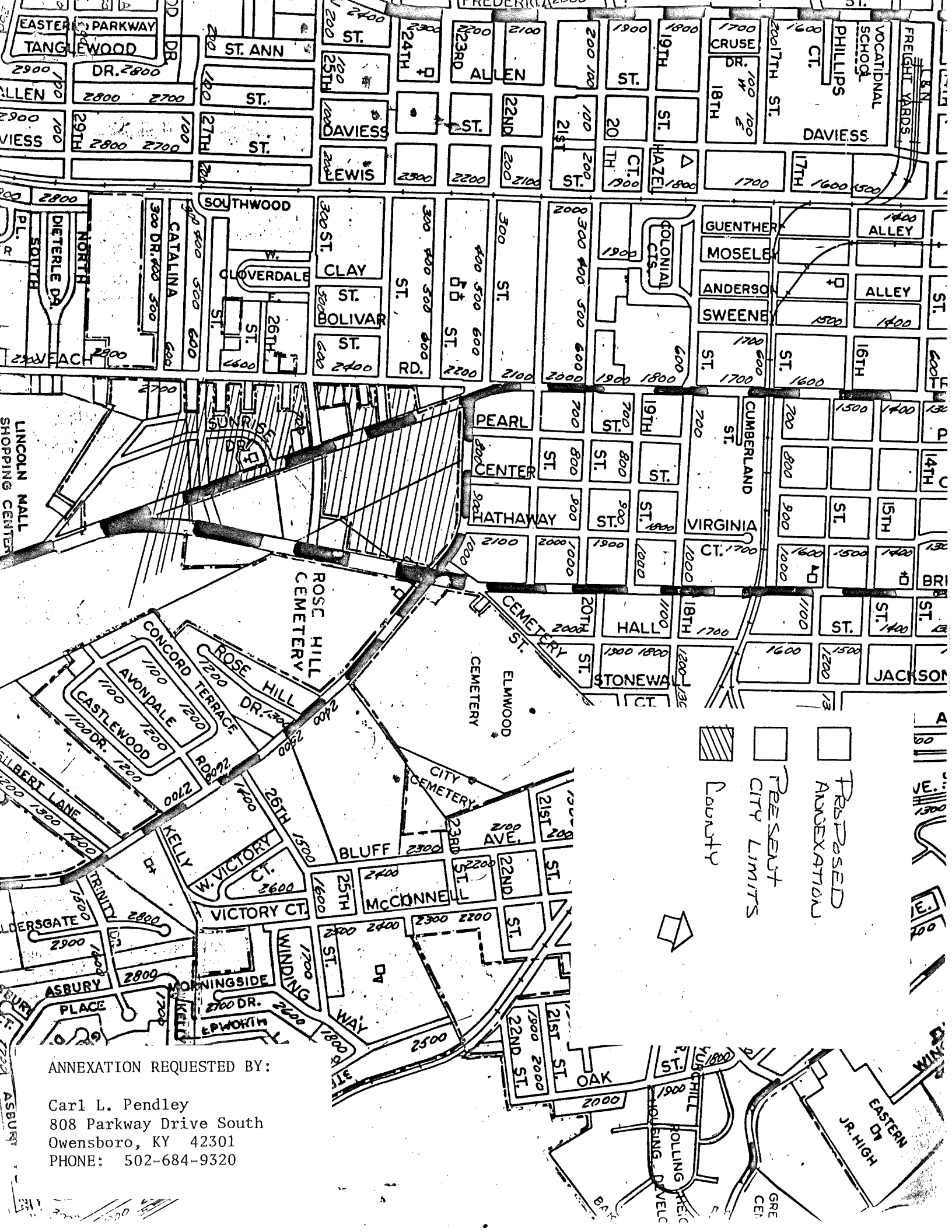
