AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING UNIT NO. 2-F OF LAKEWOOD SUBDIVISION LYING ALONG RAINTREE DRIVE, CONTAINING 4.357 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 60-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on August 19, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro,
Kentucky, and its boundary line is hereby extended so as to include within the
limits of the City of Owensboro that certain territory in the County of Daviess,
State of Kentucky, adjoining and being adjacent to the present boundary line
of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point being the northeast corner of 3817 Raintree Drive and also being in the present city limits line; thence S 6° 00° E, 120 feet to a point in the north margin of Raintree Drive; thence S 8° 19° W, and crossing Raintree Drive 51.44 feet to a point; thence S 6° 00° E, 125 feet to a point; thence S 83° 56′ W, 59.76 feet to a point; thence S 6° 08′ E, 308.80 feet to a point; thence S 83° 58′ W, 120 feet to a point in the east margin of Raintree Drive; thence S 76° 08′ W, and crossing Raintree Drive; thence S 76° 08′ W, and crossing Raintree Drive; thence to a point; thence S 83° 59′ W, 109.06 feet to a point; thence N 62° 03′ W, 19.10 feet to a point; thence N 60° 01′ W, 459.32 feet to a point; thence N 34° 26′ E, 184.92 feet to a point, thence N 84° 00′ E, 247 feet to the point of beginning and containing 4.357 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
