ORDINANCE NO. 93-86

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1812 EAST FOURTH STREET, CONTAINING 0.46 ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 86-86, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 20, 1986, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the south margin of East Fourth Street (U.S. Hwy. 60) and the east margin of Birkhead Avenue, said point also being the northwest corner of property at 1812 East Fourth Street; thence with the south margin of East Fourth Street and the present city limits N 55° 18' E 200 feet to a point; thence leaving East Fourth Street S 38° 20' 30" E, 100.00 feet to a point; thence S 55° 18' W 199.94 feet to a point in the east margin of Birkhead Avenue; thence with the east margin of Birkhead Avenue and present city limit N 38° 22' 30" W 100.00 feet to the point of beginning and containing 0.46 acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
