## ORDINANCE NO. 10-87

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING THE RIGHT-OF-WAY OF OLD U.S. HIGHWAY 231 FROM A POINT APPROXIMATELY 367 FEET SOUTH OF 27TH STREET TO A POINT APPROXIMATELY 370 FEET NORTH OF HORSE FORK CREEK, CONTAINING 4.39 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 8-87, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 4, 1987, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the west margin of the old U.S. Highway 231 right-of-way and being approximately 367 feet south of the south margin of 27th Street and being the northeast property corner of 2724 New Hartford Road; thence southwardly with the west right-of-way margin of old U.S. Highway 231 approximately 678 feet to the centerline of Ridgeway Drive; thence continuing southward and with the west margin of old U.S. Highway 231 approximately 1,597 feet to the centerline of Dixiana Drive; thence continuing southward with the west margin of U.S. Highway 231 approximately 1,138 feet to a point approximately 370 feet north of Horse Fork Creek; thence north 20° 19' 16" east and crossing old U.S. Highway 231, 77.4 feet to a point in the access control fence along the west margin of the New Hartford Road; thence northward with the New Hartford Road access control fence and the east margin of old U.S. Highway 231 approximately 3,280 feet to a point; thence northwestwardly approximately 84 feet and crossing old U.S. Highway 231 to the point of beginning, and containing 4.39 acres.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
