ORDINANCE NO. 35-87

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2174 TAMARACK ROAD, CONTAINING 0.48 ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. 29-87, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on June 16, 1987, the city proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the south right-of-way line of Tamarack Road, said point being the northeast corner of Lot #1 of the Herbert Bertke Subdivision as recorded in Deed Book 349, Page 100 and being address 2174 Tamarack Road, said point also being approximately 609 feet west of the west margin of Lovell Drive; thence south $2^{\circ} 49'$ east and with the present city limits 192.33 feet to a point in the north line of Apollo Heights Subdivision; thence south $73^{\circ} 05'$ west 112.95 feet to a point being the southwest corner of 2174 Tamarack Road; thence north $1^{\circ} 10'$ west 186.7 feet to a point in the south margin of Tamarack Road; thence north $69^{\circ} 30'$ east and with the south margin of Tamarack Road 109.2 feet to the point of beginning and containing 0.48 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
