# ORDINANCE NO. <u>39-81</u>

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 4321 CARTER ROAD, CONTAINING 0.258 ACRE, MORE OR LESS.

WHEREAS, by Ordinance No. <u>33-87</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 7, 1987, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> Beginning at a point in the east right-of-way line of Carter Road, said point being the northwest corner of 4321 Carter Road; thence south 76° 10' 30" east 150.08 feet to a point being in the present city limits line, said point also being in the west line of Tamarack Park South Subdivision; thence south 14° 41' west and with the present city limit line and with the west margin of Tamarack Park South Subdivision 75 feet to a point; thence north 76° 10' 30" west and with the present city limit line 150.16 feet to a point in the east margin of Carter Road; thence north 14° 44' 30" east and with the east margin of Carter Road 75 feet to the point of beginning and containing 0.258 acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2). INTRODUCED AND PUBLICLY READ ON FIRST READING, this the 21st day of July, 1987.
