ORDINANCE NO. 32-88

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING THE RIGHT-OF-WAY OF THE GEMINI DRIVE EXTENSION, SOUTH OF CARPENTER DRIVE, CONTAINING 1.86 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 25-88, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 5, 1988, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Southtown Boulevard and west margin of the Gemini Drive Extension, said point also being the southeast corner of the property at #2175 Southtown Boulevard, (Apollo High School); thence with the west margin of the Gemini Drive Extension and the east property line of #2175 Southtown Boulevard northwardly 1,508.50' to a point being the northeast corner of #2175 Southtown Boulevard, said point also being in the present city limit line; thence with the present city limit line and crossing Gemini Drive eastwardly 51.15' to a point in the east margin of Gemini Drive; thence with the east margin of the Gemini Drive Extension and the west line of the Frederick property, southward 1,491.8' to a point in the north margin of Southtown Boulevard, said point also being in the present city limit line; thence with the north margin of Southtown Boulevard and with the

present city limit and crossing Gemini Drive Extension westwardly 60.67' to the point of beginning and containing 1.86 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).

INTRODUCED AND PUBLICLY READ ON FIRST READING, this the 19th day of July, 1988.
