ORDINANCE NO. 33-88

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 900 OLD HARTFORD ROAD AND 2430 BRECKENRIDGE STREET, CONTAINING 9.024 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 28-88, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on July 19, 1988, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pin in the south margin of Old Hartford Road and the west margin of Breckenridge Street, said point being in the present city limits; thence with the west margin of Breckenridge Street and with the present city limits south 3 degrees 57 minutes 00 seconds west 680.29 feet; thence leaving Breckenridge Street north 86 degrees 04 minutes 55 seconds west 182.97 feet; south 29 degrees 29 minutes 25 seconds west 55.20 feet; thence leaving the present city limits north 34 degrees 05 minutes 35 seconds west 826.97 feet; north 85 degrees 24 minutes 25 seconds east 100.00 feet; north 34 degrees 06 minutes 35 seconds west 150.00 feet to a point in the south margin of Old Hartford Road, said point also being in the present city limits; thence with the south margin of Old Hartford Road and with the present city limits north 85 degrees 37 minutes 30 seconds east

316.26 feet; south 87 degrees 45 minutes 30 seconds east 111.70 feet; south 73 degrees 25 minutes 40 seconds east 104.73 feet; south 62 degrees 48 minutes 20 seconds east 154.38 feet; south 60 degrees 59 minutes 20 seconds east 45.73 feet to the point of beginning and containing 9.024 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).


