ORDINANCE NO. 43-88

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 4911 FREDERICA STREET (AT THE SOUTHEAST CORNER OF FREDERICA STREET AND SOUTHTOWN BOULEVARD), CONTAINING 3.78 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 40-88, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on October 4, 1988, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at an iron pin in the east margin of U.S. Hwy No. 431 and the south margin of Southtown Boulevard; thence with the south margin of Southtown Boulevard north 76 degrees 28 minutes 08 seconds east 45.31 feet; south 80 degrees 04 minutes 30 seconds east 283.16 feet; south 79 degrees 36 minutes 25 seconds east 30.78 feet; south 78 degrees 25 minutes 00 seconds east 49.16 feet; south 76 degrees 51 minutes 32 seconds east 48.65 feet; south 75 degrees 22 minutes 38 seconds east 48.71 feet; south 73 degrees 51 minutes 35 seconds east 48.68 feet; south 72 degrees 22 minutes 05 seconds east 33.64 feet; south 72 degrees 00 minutes 20 seconds east 535.65 feet to an iron pin; thence leaving Southtown Boulevard south 17 degrees 21 minutes 58 seconds west 158.69 feet to an iron pin; thence north 72 degrees 19 minutes 21 seconds west 1104.81 feet to an iron pin in the east margin of U.S. Hwy. No. 431; thence with the east margin of U.S. Hwy. No. 431 north 10 degrees 54 minutes 17 seconds east 83.67 feet to the point of beginning and containing 3.78 acres, as per survey by Johnson, Depp and Quisenberry.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
