ORDINANCE NO. 3-89

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2224 PARRISH AVENUE, CONTAINING .318 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 60-88, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on January 3, 1989, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point being the N.E. corner of 2224 Parrish Avenue, said point being in the south margin of Parrish Avenue 570 feet more or less west of the west margin of Bosley Road and also being in the present city limits; thence southward and with the present city limits 173.5 feet plus-minus to a point being the S.E. corner of 2224 Parrish Avenue, said point also being in the north margin of a 12 foot alley; thence westward with the north margin of the 12 foot alley 80 feet to the S.W. corner of 2224 Parrish Avenue; thence northward 173.5 feet plus-minus to a point being the N.W. corner of 2224 Parrish Avenue and said point being in the south margin of Parrish Avenue; thence eastward and with the south margin of Parrish Avenue 80' to the point of beginning and containing 0.318 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2). INTRODUCED AND PUBLICLY READ ON FIRST READING, this the

7th day of February , 1989.
