ORDINANCE NO. 12-89

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2607 VEACH ROAD, CONTAINING .309 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 7-89, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on February 21, 1989, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point being the N.W. corner to 2607 Veach Road and the S.W. corner to 2605 Veach Road, said point being in the east margin of Veach Road and also being in the present city limits; thence eastward 200 feet to a point being the N.E. corner to 2607 Veach Road and the S.E. corner to 2605 Veach Road; thence southward 67.5 feet to a point being the S.E. corner to 2633 Veach Road; thence westward 200 feet to a point being the S.W. corner to 2607 Veach Road and the N.E. corner to 2633 Veach Road; thence westward 200 feet to a point being the S.W. corner to 2607 Veach Road and the N.W. corner to 2633 Veach Road, said point also being in the east margin of Veach Road; thence with the east margin of Veach Road northwardly 67.5 feet to the point of beginning and containing 0.309 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
