ORDINANCE NO. 14-89

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 620 SALEM DRIVE AND A PORTION OF SALEM DRIVE RIGHT-OF-WAY, CONTAINING 2.20 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 9-89, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 7, 1989, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and a waiver of the sixty (60) day waiting period from the owner of the property to be annexed has been received.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the north margin of Salem Drive; thence S 10 degrees 28 minutes W and crossing Salem Drive to a point being in the south margin of Salem Drive and being the N.E. corner of 620 Salem Drive; thence S 10 degrees 28 minutes W 554.08 feet to a point being in the present city limits; thence with the present city limits N 79 degrees 32 minutes W 160 feet to a point; thence continuing with the city limits N 10 degrees 28 minutes E 543.58 feet to a point in the south margin of Salem Drive; thence N 10 degrees 28 minutes E and crossing Salem Drive to a point in the north margin of Salem Drive; thence eastwardly with the north margin of Salem Drive 160.35 feet to the point of beginning and containing 2.20 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400(2).
