## ORDINANCE NO. 35-89

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 3180 PARRISH AVENUE, CONTAINING 0.598 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 28-89, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on

July 5, 1989, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe in the west right of way line of Parrish Plaza Drive where it intersects with the south right of way line of Parrish Avenue (Ky Hwy. 81), and being in the present city limits; thence with the west right of way line of Parrish Plaza Drive and with the present city limits south 13 degrees 05 minutes 00 seconds east 186.57 feet to an iron pipe; thence south 76 degrees 55 minutes 00 seconds west 140.79 feet to an iron pipe corner to 3196 Parrish Avenue; thence with the line of 3196 Parrish Avenue north 13 degrees 05 minutes 00 seconds west 183.10 feet to an iron pipe in the south right of way line of Parrish Avenue; thence with said right of way line north 75 degrees 31 minutes 00 seconds east 140.84 feet to the point of beginning and containing 0.598 of an acre, more or less.

SECTION 2. Any dedicated streets, alleys, or easements
constituting any portion of the property to be annexed are hereby
accepted by the City of Owensboro pursuant to KRS 82.400(2).
