#### ORDINANCE NO. 10-90

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING UNIT NO. 6-B AND UNIT NO. 7 IN OWEN PARK SUBDIVISION, CONTAINING 6.79 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 1-90, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on February 6, 1990, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a stake in the north margin of Byers Avenue East, and in the present city limits, said stake being 160.78 feet east of the east margin of Burlew Boulevard; thence with the city limits north 28 degrees 54 minutes east 105.33 feet; thence south 61 degrees 29 minutes east 306 feet; thence leaving the city limits south 27 degrees 38 minutes west 308.18 feet; thence north 62 degrees 22 minutes west 56 feet; thence south 27 degrees 38 minutes west 377.18 feet; thence N 59 degrees 29 minutes W 80 feet; thence with the present city limits N 59 degrees 29 minutes W 384.60 feet; thence north 27 degrees 37 minutes east 504.98 feet to a point in the south margin of Byers Avenue; thence with the south margin of Byers Avenue, south 61 degrees 22 minutes east 220.0 feet; thence crossing Byers Avenue north 28 degrees 54 minutes east 60 feet to the point of beginning and containing 6.79 acres, more or less.
