ORDINANCE NO. 21-91

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 2504 VEACH ROAD, CONTAINING 0.15 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>15-91</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>March 5</u>, 1991, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> From a point in the south right-of-way of 25th Street and the west right-of-way of Veach road, south with the west right-of-way of Veach Road 107 feet to the point of beginning; thence with the west right-of-way of Veach Road south 48 feet to a point, said point being the northeast corner of 2506 Veach Road; thence with the north line of 2506 Veach Road west 139 feet to a point; thence with the east line of 632 East 25th Street north 48 feet; thence with the south line of 2502 Veach Road east 139 feet to the point of beginning containing 0.15 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
