AN ORDINANCE ANNEXING TO THE CITY OF OWENS BORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT THE NORTHWEST CORNER OF CARTER ROAD AND THE WENDELL FORD EXPRESSWAY, CONTAINING 5.9 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 14-91, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on March 19, 1991, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENS BORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pipe, being the southeast corner to Unit No. 9 Thorobred Acres Subdivision and in the west margin of Carter Road, said iron pipe also being in the present city limits; thence with the west margin of Carter Road S 17 degrees 07 minutes W 512.89 feet to a point in the west margin of Carter Road and in the north margin of the Wendell Ford Expressway; thence with the north margin of the Wendell Ford Expressway as follows; N 52 degrees 04 minutes W 346.32 feet to a point, N 50 degrees 48 minutes W 129.47 feet to a point, N 49 degrees 40 minutes W 141.37 feet to a point, N 47 degrees 48 minutes W 142.15 feet to a point, N 46 degrees 47 minutes W 78.53 feet to  $\bar{a}$  point, N 45 degrees 33 minutes W 198.74 feet to an iron pipe corner, in a line of Anthony Bittel; thence S 78 degrees 51 minutes E 37.56 feet to an iron pipe corner to Anthony Bittel and in a line of Unit 9 of the Thorobred Acres Subdivision, said pipe also being in the present city limits; thence with the present city limits S 78 degrees 51 minutes E 5.892 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
