ORDINANCE NO. 30-91

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY KNOWN AS ALEXANDRIA SUBDIVISION AND LOCATED IN THE 3200 BLOCK OF VEACH ROAD - CONTAINING 14.58 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 26-91, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on April 16, 1991, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at an iron pin in the east margin of Veach Road and corner to the Owensboro Country Club property; thence with the east margin of said Veach Road north 13 degrees 53 minutes 40 seconds east 276.54 feet; north 13 degrees 54 minutes east 272.43 feet; thence leaving Veach Road south 60 degrees 02 minutes east 373.88 feet, said point being in the present city limits, south 30 degrees 21 minutes west 263.81 feet; south 59 degrees 38 minutes 32 seconds east and with the south line of the Quail Ridge Condominium property 1714.85 feet to a point in Cul-De-Sac right-of-way; thence with right-of-way line of Cul-De-Sac south 45 degrees 21 minutes 39 seconds east 21.59 feet; south 18 degrees 29 minutes 50 seconds east 25.00 feet; south 10 degrees 27 minutes 24 seconds west 25.00 feet; south 39 degrees 26 minutes 25 seconds west 25.00 feet; thence leaving Cul-De-Sac right-of-way south 59 degrees 38 minutes 32 seconds east 49.49 feet; south 22 degrees 03 minutes 29 seconds west 197.27 feet; north 59 degrees 38 minutes 32 seconds west and with the north line of the Owensboro Country Club property 2055.46 feet to the point of beginning and containing 14.58 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
