ORDINANCE NO. 5-92

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING PROPERTY LOCATED AT 1920 WEST PARRISH AVENUE - CONTAINING 0.333 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>1-92</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>January 21</u>, 1992, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> **BEGINNING** at a point in the south margin of Parrish Avenue and being the northeast corner to 1920 W. Parrish Avenue; thence southward 212.71 feet to a point being the southeast corner to 1920 W. Parrish Avenue and being in the present city limits; thence with the present city limits 64.13 feet to a point being the southwest corner to 1920 W. Parrish Avenue; thence northward and leaving the present city limits 38.17 feet to a point; thence westward 6.95 feet to a point; thence northward 165.85 feet to a point; thence northward 165.85 feet to a point in the south margin of Parrish Avenue and being the northwest corner to 1920 W. Parrish Avenue; thence eastward and with the south margin of Parrish Avenue 70 feet to the point of beginning and containing 0.333 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
