ORDINANCE NO. 11-92

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING THE MID-AMERICA AIRPARK PROPERTY AND A PORTION OF CARTER ROAD, CONTAINING 322.54 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. 72-91, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on January 7, 1992, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and more than sixty (60) days have passed since the enactment of said ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

BEGINNING at a point in the east margin of Carter Road at the point where the south margin of Bullfrog Boulevard extended intersects the east margin of Carter Road; thence with the east margin of Carter Road as follows: S 13 degrees 30 minutes 11 seconds W 880.34 feet; S 12 degrees 43 minutes 43 seconds W 201.38 feet; S 13 degrees 39 minutes 12 seconds W 110 feet to a point in the south margin of Tamarack Road, said point also being in the present city limit line; thence with the present city limits S 13 degrees 39 minutes 12 seconds W 384.12 feet to a point; thence continuing with the east margin of Carter Road as follows: S 14 degrees 28 minutes 34 seconds W 1,371.71 feet; S 13 degrees 59 minutes 26 seconds W 312.65 feet; S 14 degrees 42 minutes 24 seconds W 477.61 feet to a point at the southeast corner of Carter Road and Southtown Boulevard; thence crossing Carter Road and leaving the present city limits N 76 degrees 02 minutes 46 seconds W 99.78 feet to a point in the west margin of Carter Road; thence with the west margin of Carter Road N 14 degrees 22

minutes 06 seconds E 52.42 feet; thence leaving the west margin of Carter Road as follows: N 84 degrees 23 minutes 45 seconds E 368.92 feet; S 67 degrees 35 minutes 16 seconds W 185.44 feet; N 89 degrees 07 minutes 09 seconds W 303.32 feet; S 0 degrees 29 minutes 20 seconds E 244.19 feet; S 83 degrees 40 minutes 14 seconds E 757.93 feet to a point in the west margin of Carter Road; thence with the west margin of Carter Road as follows: S 14 degrees 22 minutes 06 seconds W 1,433.22 feet; S 11 degrees 52 minutes 59 seconds W 17.79 feet; N 77 degrees 57 minutes 22 seconds W 5.00 feet; S 11 degrees 56 minutes 56 seconds W 349.99 feet; N 77 degrees 54 minutes 43 seconds W 10.05 feet; S 11 degrees 58 minutes 38 seconds W 302.69 feet to a point in the west margin of Carter Road; thence leaving the west margin of Carter Road as follows: N 68 degrees 18 minutes 57 seconds W 1,263.08 feet; N 67 degrees 52 minutes 21 seconds W 305.00 feet; N 13 degrees 01 minutes 57 seconds W 856.63 feet; N 82 degrees 30 minutes 17 seconds E 25.29 feet; N 4 degrees 14 minutes 55 seconds W 1,673.25 feet; S 85 degrees 03 minutes 23 seconds E 476.03 feet; N 12 degrees 41 minutes 03 seconds W 2,206.93 feet; N 83 degrees 36 minutes 27 seconds E 452.68 feet; N 13 degrees 07 minutes 10 seconds E 1,360.10 feet to a point in the south margin of Bullfrog Boulevard; thence with the south margin of Bullfrog Boulevard S 76 degrees 24 minutes 47 seconds E 2,660.42 feet to the beginning containing approximately 322.54 acres and being 318.87 acres of land owned by Owensboro-Daviess County Industry, Inc., and 3.67 acres of Carter Road right-of-way.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.


