ORDINANCE NO. 53-92

AN ORDINANCE ANNEXING TO THE CITY OF CERTAIN OWENSBORO, KENTUCKY, UNINCORPORATED TERRITORY IN THE COUNTY THE PRESENT DAVIESS ADJOINING OF OF THE CITY, BEING LINE BOUNDARY PROPERTY LOCATED AT 2507 VEACH ROAD -CONTAINING 0.229 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>46-92</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>September 1</u>, 1992, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a point in the east margin of Veach Road being the northwest corner of 2507 Veach Road and the southwest corner of 2505 Veach said point is also in the present city Road. limits; thence with the present city limit line east 200 feet (per deed) to a point; thence south 50 feet to a point; thence west 200 feet (per deed) to the east margin of Veach Road being the southwest corner to 2507 Veach Road and the northeast corner to 2529 Veach Road; thence with the east margin of Veach Road 50 feet to point of beginning and containing 0.229 acres, more or less.

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
