## ORDINANCE NO. 31-93

AN ORDINANCE ANNEXING TO THE CITY OF OWENSBORO, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY IN THE COUNTY OF DAVIESS ADJOINING THE PRESENT BOUNDARY LINE OF THE CITY, BEING A PORTION OF BROOKHILL SUBDIVISION (PLANNED TO BE DEVELOPED AS UNITS 4 & 5) - CONTAINING 6.8 ACRES, MORE OR LESS.

WHEREAS, by Ordinance No. <u>26-93</u>, heretofore passed by the Board of Commissioners of the City of Owensboro, Kentucky, on <u>June 15</u>, 19<u>93</u>, the City proposed to annex certain territory hereinafter more particularly described, and

WHEREAS, said ordinance has been published in the official newspaper for the city and the sixty (60) day waiting period has been waived in accordance with KRS 81A.412 by virtue of said owners application for annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF OWENSBORO, KENTUCKY, AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Owensboro, Kentucky, and its boundary line is hereby extended so as to include within the limits of the City of Owensboro that certain territory in the County of Daviess, State of Kentucky, adjoining and being adjacent to the present boundary line of the City of Owensboro, Kentucky, more particularly described as follows:

> BEGINNING at a pipe corner being the northwest corner of Lot No. 60, Unit No. 3, Brookhill Subdivision, said point being in the present city limits; thence with the line of Unit Nos. 2 & 3 of Brookhill Subdivision and with the present city limit line south 23 degrees 28 minutes east 762.2 feet (more or less) to a point being the southeast corner to Lot 81; thence south 66 degrees 32 minutes west 165 feet (more or less) to a point being the southwest corner to Lot 81 and being in the east margin of Hillbrooke Pkwy; thence crossing Hillbrooke Pkwy. south 86 degrees 59 minutes west 64.9 feet (more or less) to a point being the southeast corner to Lot 70 and being in the west margin of Hillbrooke Pkwy; thence north 24 degrees 08 minutes west 745 feet (more or less) to a point being the northwest corner to Lot 64; thence north 67 degrees 02 minutes east 399.5 feet (more or less) to the point of beginning containing 6.8 acres (more or less).

SECTION 2. Any dedicated streets, alleys, or easements constituting any portion of the property to be annexed are hereby accepted by the City of Owensboro pursuant to KRS 82.400.
